## **CLARIN-ERIC: where we stand**

The following countries have now signed the Memorandum of Understanding with the Dutch Ministry of Education and Research: Croatia, the Dutch Language Union (also representing Flanders), Estonia, Finland, France, Germany, Greece, Latvia, Lithuania and Poland. From a number of other countries we have received positive reactions, but the signature may need some time: Austria, Czech Republic, Denmark, Norway and Spain. These countries, as well as Bulgaria and Italy, have nominated a delegate (if they have signed) or observer (if they haven't signed yet) to the CLARIN-ERIC Steering Committee. The first meeting of this Steering Committee will take place in the Hague on Friday March 18. The members of the CLARIN Strategic Coordination Board have also been invited. During this meeting the documents required for the ERIC application will be presented and discussed. This includes the CLARIN-ERIC statutes, the Membership agreement and the funding model. Possibly we need a second meeting of the Steering Committee to come to a consensus on these issues. We plan to submit the final application for the CLARIN-ERIC to the EC Brussel in June this year.

### **NORWAY**

### **LATVIA**

The Ministry of Education and Science supports CLARIN activities in Latvia. In November, 2010 the Institute of Mathematics and Computers Science (IMCS), University of Latvia, signed the third agreement with the Ministry of Education and Science regarding support for implementation of the preparatory phase of the CLARIN project. By this IMCS can actively participate in the CLARIN project until the end of the preparatory phase. Besides participation in different working groups of WP5, WP2 and WP7, several national events, e.g. the CLARIN Latvia National workshop, are planned for Spring, 2011. CLARIN was presented at the annual conference of the University of Latvia. On February 3, CLARIN Latvia participated with a poster in the plenary session of the annual conference of the University of Latvia "Science financed by EU in Latvia". This plenary session is traditionally organized by the Academic Department of the University of Latvia and the National Contact Point and is mainly devoted to 7th Framework Programme activities that support fundamental research, i.e., IDEAS, PEOPLE and RESEARCH INFRASTRUCTURES. Experimental Web Services: In the scope of WG 5.6 (LRT Integration) several NLP tools for Latvian have been made available via experimental Web Services <http://valoda.ailab.lv/ws/>.

Recently some of them have been standardized according to the ISO family of standards, namely, a tokenizer and sentence splitter, a POS tagger, and a morphological analyzer. The main annotation schemes that we use are Morpho-syntactic Annotation Framework (ISO/DIS 24611) and Lexical Markup Framework (ISO 24613:2008). For specifying morphological categories we use ISocat - an implementation of the Data Category Registry (ISO 12620:2009).

### THE NETHERLANDS

In CLARIN-NL a second call for demonstrator and data curation projects has been launched. This call invited researchers to submit proposals for projects for maximally 100k euro, and the total available budget for this call is 600k euro. The following proposals were awarded a grant:
